1. Certificate Course on Self Defence and Karate

1. Deliverables:

- a. The Course shall be operated within the College premises and all infrastructural facilities essential in running the course (like washroom, drinking water, electricity, and space for conducting the class) shall be arranged in the College premises and will be the responsibility of the College authority.
- b. College will try to provide minimum 20 students batch capacity for each course respectively.
- c. The duration of the course will be of 6 months (40 hours), with one class of one hour each week. Classes may not be continuous due to University Examinations and Vacations etc.
- d. The course fee will be Rs.100/month/student.
- e. Assessment after completion of the course will be conducted Shotokan International Karate Federation, India.
- f. Assessment & Participation Certification will be provided by Shotokan International Karate Federation, India, and College jointly, mentioning both name and logo.
- g. College will provide the writing permission to use its name and logo for the joint certification of the said course only.

2. Terms of MOU:

This MOU shall be valid for a period of 1 (One) year from the date of execution and can be renewed for a further period on mutual consent and satisfaction to both contracting parties.

Shotokan International Karate Federation, India, and College Authority shall jointly review the progress of each batch.

This MOU may be amended, altered, or modified from time to time mutually decided by both the parties, however no such alteration, modification or amendment shall be operative, valid, or binding, unless reduced in writing and executed by both the parties hereto.

4. Relationship between the Parties:

It is expressly agreed that Shotokan International Karate Federation, India, and the College are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither party is authorized to use the other party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other party, without the prior written consent of the other party. Neither party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the party, to pledge the other party's credit, or to extend credit on behalf of the other party.

It is also agreed, a written confirmation given by the college to use its name and Logo to the Shotokan International Karate Federation, India only for the joint certification of the said course.

Shotokan International Karate Federation, India, will not disclose the negotiated amount or reproduce it before the students or any other organization for its further commercial gains.


7. Maintenance of Accounts:




