The Memorandum of Understanding ("MoU") is to promote academic linkages between the institutions and facilitate their development of collaborative and mutual programmes that will enhance the intellectual life of both institutions, contribute to increased cooperation and promote mutual understanding. Sundarban Mahavidyalaya, Kakdwip, South 24 Parganas, West Bengal, Pin: 743347 and Rani Birla Girls' College, 38, Shakespeare Sarani, Kolkata-700017 have agreed to the following:

**1. Framework for specific agreement**

The Memorandum of Understanding ("MoU") is a framework for specific collaborative initiatives to be developed between the two institutions.

**2. Areas of Collaboration**

Both parties have agreed to explore and implement mutually rewarding initiatives in the following areas of academic cooperation:

- 2.1 Online and Offline sharing of innovative ideas in Teaching- Learning and e- Governance;
- 2.2 Collaborative research;
- 2.3 Sharing of Academic information on areas of mutual interest;
- 2.4 Faculty and Student Exchange
- 2.5 Library Sharing
- 2.6 Joint state level/ national/ international seminars/ workshops and cultural and social programmes;
- 2.7 Other academic collaboration, including publications,
- 2.8 Extra- curricular activities including sports and cultural programmes

**3. Development of Initiatives**

Areas of cooperation will be defined between Sundarban Mahavidyalaya and Rani Birla Girls' College throughout the duration of the MoU and further agreement of academic agreements may result for specific collaborative activities.

Neither institution shall have any financial commitments to each other, nor through this MoU, real or implied. Both parties agree, however, to endeavour to secure government, corporate or other party funding where possible in order to support the collaborative activities covered by the agreement.

**4. Confidentiality and Intellectual Property Rights (IPR) protection**

Both the institutions shall respect and retain confidentiality in each/ any of the collaborative efforts, and all collaborative efforts, and all collaborative academic exercises shall be guided, directed and implemented by the greater academic interest of both the colleges, and not any other/ commercial interest.

This MoU will respect Intellectual Property Rights and any intellectual matter, developed by the collaborative efforts of two institutions, shall be retained by them.

**5. Duration, Amendment and Termination of MoU**

This MoU will remain in effect for a period of (05) five years from the date of signing. It can be amended at any time by mutual agreement and writing as an addendum. No legal relationship between the two institutions is implied through this agreement. Either party may terminate this MoU at any time and for any reason by giving the other party at least (03) three months written notice of its decision. There will be no monetary transaction between the institutions.
