MANAGEMENT-POST CREATION

Rani Birla Girls' College, since its initiation as a Government-Aided College under the Government of West Bengal, has created 8 (eight) management-posts (Governing Body posts) and appointed teachers in those posts.

The first among these were a management post created for the ***Department of Sociology***. The department, started its journey as a General department, but applied for affiliation as an Honours department in 2004, and the affiliating University, i.e. the University of Calcutta, conducted an inspection for the same on 31/05/2004. In the inspection report of the University of Calcutta, the college was directed to appoint **1 (one) full-time teacher** above the present posts. Accordingly, the management post was created and Ms. Debarchana Dutta, was appointed in the post of Lecturer in Sociology in September 2005.

The second department to appoint full-time teacher in Management-created post was the ***Department of Communicative English***. The college initiated this course from the academic session 2006-2007, inspection for which was conducted on 20/07/2006 by the University of Calcutta. In the inspection report of the University of Calcutta, the college was directed to appoint **1 (one) full-time** teacher for the department. Accordingly, the management post was created and Dr. Angana Sanyal, was appointed in the post of lecturer in Communicative English in August 2006.

The next department to create and appoint teachers in management-posts was the ***Department of Journalism and Mass Communication***. The college initiated this course from the academic session 2007-2008, inspection for which was conducted on 17/08/2006, by the University of Calcutta. In the inspection report of the University of Calcutta, the college was directed to appoint **3 (three) full-time teachers** for the department. Accordingly, the management posts were created and Ms. Trina

Bhattacharya, was appointed in the post of lecturer in Journalism and Mass Communication in August 2007. Mr. Debarshi Bhattacharyya and Ms. Ishita Biswas was appointed in August 2014 and March 2015 in management-posts created at the inception of the departments and previously served by other appointees who had eventually resigned.

The last department to create and appoint teachers in management-posts was the ***Department of Fashion and Apparel Designing***. The college initiated this course from the academic session 2008-2009, inspection for which was conducted on 19/06/2008 by the University of Calcutta. In the inspection report of the University of Calcutta, the college was directed to appoint **3 (three) full-time teachers** for the department. Accordingly, the management posts were created and Dr. Sharmistha Mukherjee, Dr. Sunanda Roy Mitra was appointed in January 2010 and Ms. Pubalina Samanta was appointed in September 2016 in the three management-posts created at the inception of the departments and previously served by other appointees who had eventually resigned.

*All these **8 (eight) management-posts** were converted to State Aided College Teacher (SACT) posts from 01/01/2020, by the Department of Higher Education Government of West Bengal and therefore was effective only till 31/12/2019. (i.e. effective for the session 2018-19 of the assessment period)*
