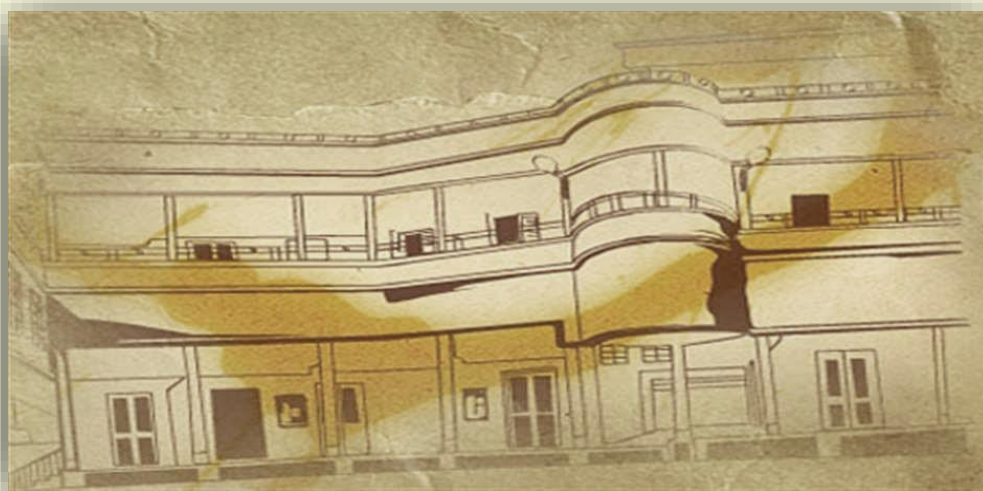

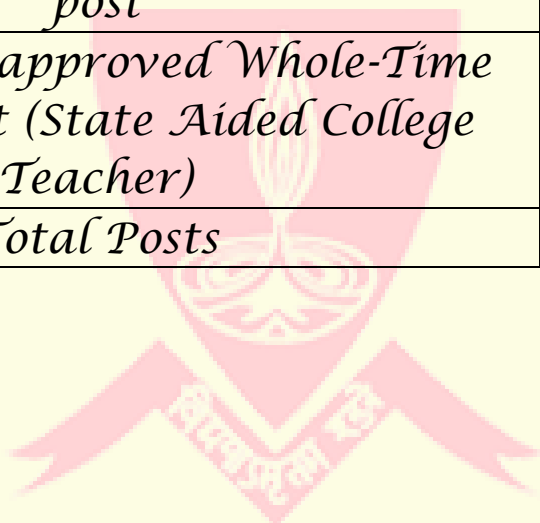

The college was established in 1961 as a Trust College run by the Hindustan Charity Trust formed by the Birla Group. The College functioned as a trust run private college affiliated to the University of Calcutta for around four decades till 1997. During this period recruitment for all teaching and non-teaching posts was done by the college through a selection committee formed by the trust and with representatives from the affiliating university.

With effect from 01/07/1997 the college transitioned from being a Trust College to a Government- Aided College and the teaching staff of the college were brought under the umbrella of West Bengal Non-Government Colleges (Payment & Salaries) Act, 1976 [vide G.O No. 224-Edn (CS) dated 30/03/1998]. Subsequently fixation of pay of 20 existing teachers on the college payroll was revised & fixed as per the new UGC Pay-Scale, 1986 by the Director of Public Instructions, Education Directorate, Government of West Bengal [vide order no 1754-UGC dated 14/12/98]

On 23/03/1999 the selection of four teachers Ms. Sushmita Das, Ms. Apala Barat, Ms. Charlotte Simpson & Ms. Sangeeta Dasgupta, made by the college during the transition period, was approved by the Director of Public Instructions, Education Directorate, Government of West Bengal [vide order 302 UGC dated 23/02/99]. Subsequently, pay fixation of three teachers, Ms. Sushmita Das, Ms. Apala Barat, Ms. Charlotte Simpson (Ms. Sangeeta Dasgupta did not join) was done by Director of Public Instructions, Education Directorate, Government of

West Bengal [vide order no.682-UGC 4P-288-UGC/98 dated 22/04/1999].

On 01/12/1999 the post of Librarian was also brought under the umbrella of West Bengal Non- Government Colleges (Payment & Salaries) Act, 1976 [vide G.O No. 1413 dated 01/12/1999]

Fixation of 24 teaching posts was done under the revised UGC scale of 1996 w.e.f. 01/07/1997 [vide order No.2156 dated 09/07/99].

The post of Librarian was approved and pay was fixed [vide order no. 774-UGC dated 5/4/2000 and order no.150-UGC Dated 12/01/2001, w.e.f. 14/07/97]

The post of one more teacher in Bengali was fixed and approved [vide order no. 2028-ugc dated 13/09/2001 w.e.f 1/7/97]

On 30/11/2000 [Vide order No 1400- Edn. (CS)] dated 30/11/2000] the College was directed to appoint all faculties for the post of Lecturer including the Principal and Librarian through the West Bengal College Service Commission (WBCSC).

Subsequently, the first teacher recommended by the WBCSC and appointed by the 'Rani Birla Girls' College was Ms. Jyoti Gurpeet Walia, Lecturer in History with effect from 07/11/2002 in the post vacated due to retirement of Smt. Krishna Mukherjee, who retired on 01/09/2001, and whose post was created/approved while change of college from trust run Private College to Government-Aided College [as explained previously, vide order No.224-Edn (CS) dated 30/3/1998 and No.2156 dated 09/07/99.]

Hence forth all recruitments for Lecturers, Librarian & Principal till date has been done vide recommendation of

WBCSC & in the vacant posts created by retirement of teachers whose post was created/approved by the Higher Education Department, Government of West Bengal, vide G.O No. 224-Edn (CS) dated 30/03/1998.

The first Principal, Dr. Sunetra Sinha, of the Government-Aided College was appointed by the Governing Body on 19/04/2005 and her service was fixed vide order No. 778-UGC dated 24/06/2005 by the Director of Public Instruction, West Bengal.

26 Posts including that of the Principal & Librarian was created and approved in the above-mentioned manner so there is no separate post creation memo against these individual posts.

Only two new teaching posts were created and approved in the departments of Geography & Sociology by the Education Directorate, Govt. of West Bengal [vide memo no 93-Edn (CS) dated 7th February 2006 and memo no.506 Edn (C.S) dated 6th August 2008], after the college started functioning as a Government -Aided College.

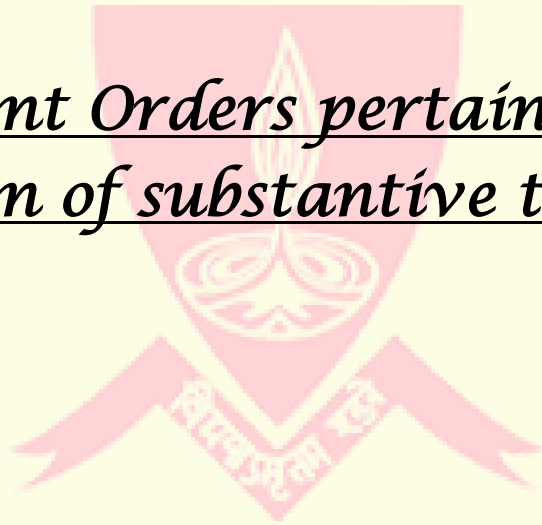

The undersigned is directed to say that the question of extending the benefit of the West Bengal Non-Govt. Colleges(Payment & Salaries) Act, 1976 to the teaching staff of Rani Birla Girls' College, Calcutta was under consideration of this Deptt. for some time past.

The Governor, after due consideration, has been pleased to decide that the teaching staff of Rani Birla Girls' College, Calcutta be brought under the umbrella of the above mentioned Act w.e.f.1/7/97 for payment of difference of salaries applicable to the teaching staff and the amount paid by the college itself, on the following terms & conditions:-

- 1) The fees structure as on 1.7.97 should not be changed without permission from the Govt. in the Deptt. of Higher Education. In order to ensure this, periodic inspection as would be decided by the D.P.I., West Bengal will be conducted by visiting the college and examining the Books of Accounts and relevant documents in terms of the W.B. Universities(Control of Expenditure).Act, 1976. Any violation on the part of the college would lead to the forfeiture of the benefit now extended.
- 2) No new post should be created, over and above the posts as on the date of the issue of this order and no post should be filled up, without prior concurrence of the Govt. in the Deptt. of Higher Education.
- 3) Modalities of recruitment of teachers will be worked out later on. This order issues with the concurrence of the Finance Deptt. vide their U.O.No.'Gr'B'-2164 dt.18-3-98.

Memorandum

The matter of restructuring of service conditions and other benefits for Government approved Part Time teachers (PTTs), Government approved Contractual Whole time teachers (CWTTs) and Guest teachers, in any nomenclature, engaged in different Government/ Government aided colleges in the State of West Bengal up to 13.07.2019, was under active consideration of the State Government for sometimes past. After careful consideration of the matter, the Governor is hereby pleased, in supersession of all previous orders in this regard, to restructure the service conditions along with the change of nomenclature of the aforesaid category of teachers commensurate with their qualifications and period of service rendered in the following manner:-

1. Part Time Teachers, Contractual Whole Time Teachers and Guest Teachers having qualification for being appointed as teachers in the colleges as prescribed by the University Grants Commission and as followed by the West Bengal College Service Commission, on the date of issuance of this order, will be renamed as **State Aided College Teacher, Category-I**, and will be entitled for the following remuneration:

- a. Rs. 31,000/- (consolidated) per month for those served the college less than 10 years;
- b. Rs. 35,000/- (consolidated) per month for those served the college more than 10 years;

2. Part Time Teachers, Contractual Whole Time Teachers and Guest Teachers don't having qualification for being appointed as teachers in the colleges as prescribed by the University Grants Commission, and as followed by the West Bengal College Service Commission on the date of issuance of this order, will be renamed as **State Aided College Teacher, Category-II** and will be entitled for the following remuneration:

- c. Rs. 20,000/- (consolidated) per month for those served the college less than 10 years;
- d. Rs.25,000/- (consolidated) per month for those served the college more than 10 years;

3. Remuneration of existing Government approved PTTs and CWTTs, who are getting higher remuneration at present, shall be protected.

4. Remuneration of above mentioned category of teachers will be enhanced @ 3% of the total remuneration per year on 1st July of every year.

5. Such category of teachers will be entitled for Rs. 5.00 Lakh (Five Lakh) only on attaining the age of 60 years, provided the teacher concerned has rendered service for a period not less than 10 years.

6. State Aided College Teacher, Category-II, on acquirement of UGC qualifications subsequently will be considered as State Aided College Teacher, Category-I with effect from the date of acquiring such qualification, subject to the approval of DPI, West Bengal.

7. General conditions in respect of approval of all the state aided College teachers mentioned above:-


- I. Fresh letter of engagement will be issued by the college authority to all category of teachers mentioned hereinabove after obtaining approval of the Director of Public Instructions, West Bengal.
- II. Notional vacancies are to be created to accommodate all State Aided College Teachers who are engaged as per 7(I) above and these posts would be treated as personal and supernumerary ones.
- III. Both the above two category of teachers (i.e. State Aided College Teacher, Category-I & Category-II) will be allowed to continue their engagement till they attain the age of 60 years. However, service of any particular teacher of above categories may be terminated by the Governing Body, with the approval of the State Government for non-performance, incapacitation, delinquency, misconduct, involvement in any criminal case or any other culpable offence, in such manner as may be prescribed by the State Government.
- IV. The above category of teachers will be required to take classes, along with works related to examination etc, as per the following schedule:-
 - a. State Aided College Teacher, Category-I: 15 hours per week.
 - b. State Aided College Teacher, Category-II: 15 hours per week.
- V. The benefit of this Order shall be allowed to the Part Time Teachers, Contractual Whole Time Teachers and Guest Teachers who were engaged in the college on or before 13.07.2019.
- VI. If required, the above category of teachers may be deployed in any other Govt. aided colleges in the interest of public service.
- VII. **The financial benefit will however, be effective from the 1st day of January, 2020.**
